### RELEASE FORM

Vaccination for rabies within 3 yr is required for dogs. We retain the right to refuse service to pets not so vaccinated. Flea preventative is required (such as Frontline, Program, K-9 Advantix, etc). If the state of the pet's health requires veterinary care, we reserve the right to call a veterinarian, or administer minor first aid at our discretion and at the owner's expense. If infested upon arrival to the Kennel, dogs will be bathed and treated for fleas/ticks at owner's expense. **We will attempt to call you if we have any problems.**

THE MAXIMUM OF \$ \_\_\_\_\_ MAY BE SPENT IN THE CASE OF A SERIOUS EMERGENCY.

All pets are boarded and /or groomed without liability on our part for loss or damage from disease, death, running away, theft, fire injury to persons, injury to or by other pets, or injury to property by said pet, or other unavoidable causes (lightning, snake bite & other, acts of God, etc). We retain the right to refuse service to destructive dogs (that chew gating, hoses, wood or kennel flap doors). We agree to exercise due and reasonable care and to keep our kennel premises sanitary and properly enclosed. The pet will be fed regularly and properly and will be housed in clean, safe quarters. The pet will not be taken off the premises except by the consent of the owner, or at the direction of the owner or in **our discretion in the case of illness when we determine the pet must be taken to a veterinarian**. The owner agrees to pay for all services rendered by this facility. Unless so noted, charges for boarding will be in 1 day increments, commencing when the pet is dropped off and ceases when the pet is picked up. **At 6:00 PM another day's fee will be added.** Payment in full must be made in advance if boarding more than 2 weeks or monthly; otherwise, payment is to be made when the pet is picked up. Pets not claimed within 7 days of scheduled pick up will be disposed of at our discretion. The owner agrees to pay all legal fees necessary to collect pet care expenses.

The signing of this contract denotes blanket consent for any and all times our boarding, grooming or training services are provided for your dog(s).
